ORDINANCE OF PENN TOWNSHIP

ORDINANCE NO. 2015 - 08

AN ORDINANCE ESTABLISHING THE MAXIMUM SPEED LIMIT FOR CERTAIN TOWNSHIP ROADS LOCATED AND MAINTAINED IN PENN TOWNSHIP AND ESTABLISHING PENALITIES FOR VIOLATIONS THEREOF.

WHEREAS, the Township of Penn is a Local Authority, under the Pennsylvania Vehicle Code (Act of June 17, 1976, P.L. 162, No. 81), as amended (75 Pa.C.S.A. 101, et seq.) having certain roads or highways under its jurisdiction; and

WHEREAS, pursuant to Section 3363 of said Vehicle Code, said Township of Penn has caused certain traffic investigations to be made of certain township roads or highways; and

WHEREAS, said investigations have determined that the maximum speed permitted under said Vehicle Code is greater than is reasonable and safe under the conditions found to exist upon those roads or highways so investigated; and

WHEREAS, said Township of Penn deems it in the best interest of its residents and the users of said roads and highways to establish reasonable and safe maximum speed limits for said roads or highways.

NOW, THEREFORE, BE IT ENACTED AND ORDAINED and it is hereby enacted and ordained by the Board of Supervisors in and for the Township of Penn, Cumberland County, Pennsylvania, as follows:

SECTION 1: PREAMBLE AND POLICY

The foregoing paragraphs or preamble are incorporated herein as the background and policy of this Ordinance.

SECTION 2: DEFINITION AND INTERPRETATION

Words and phrases used in this Ordinance shall have the meanings ascribed to them in the Pennsylvania Code (Act of June 17, 1976, P.L. No. 81), as amended, except that in this Ordinance the word "road" may be used interchangeably with the word "highway" and shall have the same meaning as the word "highway" as defined in the Vehicle Code.

SECTION 3: MAXIMUM SPEED LIMITS ESTABLISHED ON CERTAIN ROADS AND PENALTIES FOR VIOLATION THEREOF.

(a) Maximum speed limits for vehicles are hereby established for the following specified roads as follows:

Beecher Drive (T-435)	20 MPH
Bradi Drive (T-434)	20 MPH
David Glenn Drive (T-436)	
Deer Ridge Lane (T-364)	
Fox Hollow Lane (T-363)	20 MPH
Irish Gap Road (T-810)	20 MPH
Point Road (T-351)	25 MPH
High Mountain Road (T-335)	
Peach Orchard Road (T-344)	
Seavers Road (T-347)	35 MPH (w/10 MPH curve)
Smith Road (T-346)	
Kelly Road (T-345)	25 MPH
McCullough Road (T-631)	25 MPH
Farm Road South (T-343)	25 MPH

- (b) It shall be unlawful for any person to drive a vehicle on any part of a road where the foregoing maximum speed limits apply at a higher speed than the maximum prescribed for said road or part of road.
- (c) Upon conviction by a District Justice shall pay a fine in an amount consistent with the applicable fine set forth in the Pennsylvania Motor Vehicle Code at the time of the violation.

SECTION 4: REQUIREMENT TO DRIVE VEHICLE AT SAFE SPEED

The foregoing provisions shall not relieve the drivers of vehicle from complying with Section 3361 of said Vehicle Code which is incorporated herein and made a part of this Ordinance as follows:

No person shall drive a vehicle at a speed greater than is reasonable and prudent under the conditions and having regard to the actual and potential hazards then existing, nor at a speed greater than will permit the driver to bring his vehicle to a stop within the assured clear distance ahead. Consistent with the foregoing, every person shall drive at a safe and appropriate speed when approaching a crossing, when approaching and going around a curve, when approaching hill crest, when traveling upon any narrow or winding roadway and when special hazards exist with respect to pedestrians or other traffic, and reasons of weather or highway conditions.

SECTION 5: SEVERABILITY

The provisions of this Ordinance shall be severable, and if any of its provisions shall be held to be unconstitutional, illegal or otherwise invalid, that decision shall not affect the validity of any of the remaining provisions of this Ordinance. It is declared to be the legislative intention that this Ordinance would have been enacted had the unconstitutional, illegal or otherwise invalid provisions not been included in the Ordinance.

SECTION 6: CONTINUATION OF EXISTING REGULATIONS

The provisions of this Ordinance insofar as they are the same as those ordinances and regulations in force immediately before the enactment of this Ordinance are intended as a continuation of those earlier ordinances and regulations. Nothing in this Ordinance shall affect any act done or any suit or prosecution pending or to be instituted under any earlier ordinances or regulations repealed or superseded hereby.

SECTION 7: REPEAL OF CERTAIN PRIOR ORDINANCES

All prior ordinances of this Township insofar as they deal with the precise subject matter of this Ordinance are repealed and declared to be unenforceable insofar as they are inconsistent with any provision of this Ordinance.

SECTION 8: EFFECTIVE DATE

This Ordinance shall take effect in accordance with existing law.
