

**SKATEBOARDING ORDINANCE
OF PENN TOWNSHIP**

ORDINANCE NO. ___ OF 2008

AN ORDINANCE OF THE TOWNSHIP OF PENN TOWNSHIP COUNTY, PENNSYLVANIA, PROVIDING FOR THE PROHIBITION OF SKATEBOARDING ON LANDS AND EXISTING FACILITIES OWNED AND LEASED BY THE TOWNSHIP OF PENN, PROVIDING THE PENALTIES FOR VIOLATION THEREOF, TO BE KNOWN AS THE SKATEBOARDING ORDINANCE OF PENN TOWNSHIP

NOW, THEREFORE, BE IT ENACTED AND ORDAINED by the Board of Supervisors of the Township of Penn, Cumberland County, Commonwealth of Pennsylvania, and it is hereby enacted and ordained by the authority of the same that:

SECTION I: ALL SKATEBOARDING IS PROHIBITED ON LANDS AND EXISTING FACILITIES OWNED AND LEASED BY PENN TOWNSHIP.

- A. General Rule – The practice of skateboarding is prohibited on all lands and existing facilities owned and leased by Penn Township, Cumberland County, Pennsylvania.

SECTION II: PROHIBITIONS IN SPECIFIED PLACES.

All skateboarding is prohibited on the lands and existing facilities owned and leased by Penn Township, being specifically designated as the Penn Township Municipal Building located at 1301 Centerville Road, Newville, Cumberland County, Pennsylvania; the Community Center located in Centerville; the hiking/biking trail, and the playground facilities situate at 1750 Pine Road, Newville, Pennsylvania 17241.

SECTION III: PENALTIES.

- A. Violations of Section II. Any person violating the provisions of Section II of this Ordinance shall be guilty of a summary offense, and upon conviction before a magistrate shall be fined \$50.00 (fifty) plus costs of prosecution. In default of the payment of any fine, such person shall be liable for imprisonment of not more than ten (10) days in Cumberland County Prison. Any subsequent violation shall result in increased fines of \$100.00 for every subsequent violation for a maximum of \$300.00 or thirty (30) days in prison.

SECTION IV: SEVERABILITY.

The provisions of this Ordinance are severable. If any section, sentence, clause or phrase of this Ordinance shall be held illegal, invalid, unconstitutional by any court of competent jurisdiction, such decision of the court shall not affect or impair the remaining sections, sentences, clauses, or phrases of this Ordinance.

It is hereby declared as the intent of the Board of Supervisors of Penn Township that this Ordinance would have been adopted had such invalid or unconstitutional section, sentence, clause or phrase not been included herein. Furthermore, it is the intent of this Ordinance to be supplementary to and not contrary to any laws of the Commonwealth of Pennsylvania or regulations of any of its executive agencies.

SECTION V: REPEALER.

All ordinances or parts of ordinances that are inconsistent herewith are hereby repealed

SECTION VI: EFFECTIVE DATE.

This Ordinance shall take effect and be enforced from and after its approval as provided by law.
